## A Taste of Torino (Carole Calvert-Baxter)



The Intercity Dinner on February 28th was nothing short of *fantastico*, *magnifico*. *Grazie infinite* Chandra Morse and the members of this year's Intercity Committee for creating the ambiance one would expect if sitting in an Italian café. The pictorial presentation took us on a tour through the countryside of Italy. Your efforts provided us with a wonderful setting to share time with our sister Zontians from the Zonta Clubs of Saginaw and Mt. Pleasant.

As an icebreaker, when you signed in, you had to pick a name tag. The tag had either a name of a woman who changed the world or a clue describing a woman's contribution. The object was to find the person who matched your name or clue. It wasn't unusual to hear members start a conversation by saying, "I don't have a clue....do you?"

Laura Wolak, our keynote speaker shared her love of travel and her Italy experience. Her description of the aromas of Italian cuisine, tomatoes and basil, drew us further into our Italian experience. Laura asked us to visualize a kitchen pantry full of jars, some higher than others, but all containing opportunities. She reminded us that some jars are low and easy to reach, other jars are higher and more difficult to reach, and some jars are so high they are invisible. She encouraged us to see the invisible jars as opportunities that will make us stretch.

Laura's first invisible jar was the highest hill in town. She was the first girl to ride her bike to the top without stopping. In high school her Japanese studies sparked her interest in Japan. # Midland County is not Immune

Audra Johnson from Shelterhouse spoke at our Business Meeting on February 7 about domestic violence and sexual assault, especially as these crimes relate to Midland County. April is Sexual Assault Awareness Month and the presentation introduced statistics that show how sexual assaults affect women, children, and family members in Midland County.



According to a 2010 CDC (Centers for Disease Control) survey, 1 in 5 women will be raped in their lifetime. Midland County's population in 2010 was 83,629, with 42,567 being women. That means 8,513 Midland County women could experience rape. Not included in this number are the children and families impacted by assault, which dramatically in-

creases the number of people directly affected by these crimes.

Audra reported that in 2010 there were 88 criminal sexual conduct (CSC) calls, which could be any sort of

sexual contact, including rape. Considering that 60% of sexual assaults go unreported, the real number is closer to 220 in one year. Shelterhouse served over 200 sexual assault clients in 2010, including family members.

Myths and attitudes about sexual assault are prevalent in society and in even the most astute publications. Audra described articles from the Washington Post and Huffington Post to prove her point. The article from the Washington Post claimed that the CDC survey was overstating the figures. In the Comments Section, someone was insulted by the numbers because they made "too many rapists." The Huffington Post reported on elementary school children playing "rape tag" where the players tag private parts. General attitudes are reflected in pro-rape Facebook pages,



in the telling of sexual assault jokes, and in the comments sections of newspapers and magazines.

In closing, Audra reminded everyone of Denim Day, April 13, 2012. Denim Day is a campaign to raise awareness and educate the public about rape and sexual assault. The movement arose from the outrage that followed an Italian Supreme Court decision in 1998 to overturn a rape conviction because the victim wore tight



jeans. Schools and businesses can participate by encouraging students and employees to wear denim and teal ribbons and/or display the Denim Day sticker.

The "Stop the Violence" display above was shown at our InterCity Dinner meeting on February 28th. Our Zonta Club will continue to raise awareness and support local havens like Shelterhouse.

Some donations began trickling in and her jar moved from invisible to possible. Her vision became a reality when the VP of Nissan in Detroit wrote a check for \$700.

Laura received her degree while living in Australia. The next leg of her journey was to Italy. Her next jar of opportunity became a reality when her English resume landed her a job in Milan for an internet startup company of gourmet foods and high fashion. Laura married her husband, Andrea. Her husband's job resulted in Laura and her family moving back to United States.



Laura currently resides in Midland and works for Dow Chemical. While she continues to stretch, her positive experience has moved her to place her focus on putting jars within reach for other women. Laura works with Marie Eckstein to help women in Cambodia find their jars. In closing, Laura encouraged us to continue to not only find our jars, but to use our collective talent and energy to place jars in the reach of the women around us.



Linda Goltz won the Starbucks basket raffled by the Zonta Club of Saginaw.

Each club gave a brief summary of their respective operations during the remainder of the program. Nicole Swackhamer, the Vice President from the Zonta Club of Saginaw shared the key focus of the club. Saginaw continues to provide financial support to the Haiti Foundation Against Poverty. This foundation was developed by Mallery Thurlow, a Midland resident in 2007. Additionally the Saginaw club supports the white ribbon campaign and the Underground Railroad, a shelter for battered women. They provided the financial support to decorate and maintain two rooms in the residence.

Mary Jane Flanagan from the Zonta Club of Mt. Pleasant informed us that the club was chartered in 1962 and is 50 years old. In October the club hosted its 24<sup>th</sup> Annual Applefest, a fundraising event that showcases crafters from the Mt. Pleasant area. The event is family focused and an annual event that is highly anticipated by the members of the community. The proceeds go to support Women's Aid Service, Morey Cancer Center, Hospice, and the Summer Reading Clinic at Central Michigan University. Applefest is held the first Saturday of October each year.

Cynthia Chilcote, President of the Zonta Club of Midland, provided a brief overview of the fundraising activi-

ties and service projects that the Zonta Club of Midland is involved in or supports. The club hosted its 31<sup>st</sup> annual Homewalk in 2011. This year's event was highly successful and resulted in the club's ability to provide nine (9) scholarships to area students. Other projects include the Share the Memories Prom Dress project, Shelterhouse's annual Christmas Party, and the Literacy Council's Greatest Dessert Party.

The event served to not only solidify friendships across the clubs, it reminded us that our collective efforts are essential as we serve to place jars full of opportunities within the reach of the women in our communities and around the world.

### Member Highlight: Julie Ratcliffe



Julie was born the 4th child of parents living in married student housing in Wisconsin. She doesn't remember being poor, but knows now that she was. She grew up in Sudbury, MA, where she graduated at the end of her junior year in high school because Dow Chemical transferred her dad to Midland that year.

Wow! What a culture shock. She was 16 and really didn't have any friends or plans. Julie didn't think she was ready for college, so she took her senior year at Midland High in 1975-76. She took three classes and worked a co-op job in the display department at Sears in the Fashion Square Mall. Julie worked different selling jobs at Sears as well as in the gift-wrapping department.

Julie really wanted to go to college to major in ballet/dance and computer science. She was accepted at Indiana University and moved to Bloomington, IN, to begin college life.

It didn't last long. She was really homesick and the campus was overwhelming. So, Julie transferred to the College of DuPage in Wheaton, IL, where she earned a full scholarship. Her time at DuPage was cut short when she became pregnant and moved back to Midland.

Julie married and returned to work at Sears in Saginaw. Two children later, Jennifer in 1978 and Christopher in 1979, Julie and her husband divorced. With only \$25/month in child support, Julie was pretty low on funds and hope. However, because she had a supportive family (on both sides) and wonderful children, a full-time job in the cosmetics department at Eastlawn Pharmacy, and lived in low-income housing, she managed.

While working at Eastlawn Pharmacy, Julie met her second husband, Chris. He was a contractor from Mt. Pleasant hired to do some renovations at the pharmacy. He didn't have much either, but they hit it off and were married in 1984. Chris started his own contracting business in Midland and they bought a house. In 1985 they welcomed Julie's third child, Gabriel, into the family.

For several years Julie worked on the job site with Chris learning from the ground up how to build new homes. In 1990 she started working part time at Haddix Lumber where her career was born. With a lot of on-the-job training, mentoring with Jeff Bartlett, and classroom work, she learned what she loves to do. Julie says her husband introduced her to a world she would never have known otherwise.

Since then, Julie has worked with passion and motivation to become the best kitchen and bath designer she could be. In October 2010, she opened her own shop. From Ratcliffe Builders to Haddix Lumber to By Design to All About Kitchens & Baths to LeBeau Cabinets to now: Designed by Julie LLC Kitchen & Bath Studio....in Julie's words, "I live my dream."
