Brainworks—Keeping Us Sharp

Memory games and tips for better brain health kept members of the Zonta Club of Midland engaged and smiling during Jim Wiaduck's presentation at our dinner meeting on March 18th. The evening began at the check-in table with a page of puzzles assembled by the Fellowship Committee to get everyone involved right from the start.

Jim, a financial advisor with the Advisor Solutions Group at Janus, presented a program developed by Heidi Hanna, PhD, designed to help people

keep their brains active and flexible as they age. According to Jim's slide show, the brain's functions begin to decline in your late 20s and early 30s. To prove his point, he showed a slide with 18 pictures on it and gave us 30 seconds to absorb it. Then he gave us a minute to recall, in order, all the pictures we could. Needless to say, no one got all 18 pictures. In fact, a majority of the members got less than 50%.



Discussing the "Fab Five" for brain health, Jim shared how we can improve brain activity and acuity by eating the right foods, getting enough rest, exercising regularly, balancing stress, and maintaining a supportive social life. He recommended that we complete the Brain Health Assessment at the back of his handout to determine our strengths and weaknesses so we can design our own brain fitness program.

In parting, Jim asked us to re-take the picture memory test. Remarkably, most people remembered more pictures in the right location the second time around. That made us all feel better!

Proposed Bylaws Changes up for Vote

The Bylaws Committee presented these proposed changes at the March business meeting but are adding one additional change. Rather than specifying that the 2nd vice-president chair the Ways and Means Committee, they are proposing that the 2nd vice-president chair <u>a</u> committee for the club. (Changes from the original by-laws are in italics.)

Article VI - Dues

Section 2. Annual Dues

D. Missed Meals. *Members who RSVP for the meal and do not come will be charged for that meal. (Excepted from this are members who have paid for all meals in advance for that year.)* Members are expected to pay missed meal charges as soon as possible. Missed meal charges outstanding on April 1 shall be added to the member's payment due on that date. If the full payment due is not received, including the missed meal charges added to the payment due, the member shall be considered in arrears for dues.

E. Guest Meals. Zonta Club of Midland will pay for the first guest meal for a prospective member. (However, the April auction must be paid for by the guest or the member inviting that guest.) After the initial meal cost covered by the club, members bringing guests to meetings are responsible for payment for their guests' meals. Members are expected to pay guest meal fees at the meeting the guest attends. Guest meal fees outstanding on April 1 shall be added to the member's payment due on that date. IF the full payment due is not received, including the missed meal charges added to the payment due, the member shall be considered in arrears for dues.

Article VII - Officers and Directors

Section 7. Duties of officers

C. 2nd Vice President. The 2nd Vice President, in the absence or inability of the President and the 1st Vice President, shall perform the duties of the President. The 2nd Vice President shall also chair one committee, as agreed upon by the Nominating Committee.

Article XI - Committees

Section 1. Add *Advocacy Committee* to the committee list.

Section 2. Appointment. Committee Chairs shall be duly elected members of the club board. *The Homewalk Chairperson shall be appointed by the board in January of each year, due to timing of Homewalk. In addition, any board vacancies will be filled by appointment.*

Section 4. Duties of Committees.

N. Advocacy Committee. It shall recommend action in accordance with the objects of Zonta International to improve the status of women and to promote legislative awareness, advocacy, and equal rights.


Article VIII-Meetings and Conduct of Business

Section 6: Voting. Voting on matters of business requiring action of the membership may take place by voice, by written ballot or by electronic communication. Members responding by electronic means shall be considered "present and voting." A simple majority of the regular, dues paying membership is required for approval or passage, except that proposed amendments to the club Bylaws shall require a 2/3 majority vote (See Article XVI).

Article XVI: Amendment of Bylaws

The club membership, by vote of two-thirds (2/3) of its members may amend these Bylaws in a manner consistent with the policies of Zonta International at any regular or special meeting called for that purpose, provided that notice of such proposed amendment has been given to each member at least 10 days before the meeting. Such notice may be via physical or electronic means. Notice by either method is effective when sent. The vote may be taken by voice, written ballot or electronic means.

Survey Results Regarding Dues



The majority of the club voted for Option #1, which was to split the dues from meal costs. This means annual dues will be \$160 with meals paid for as you attend meetings.

Karla sent invoices reflecting this new method. We pay our International and district dues in May so we are asking members to pay their dues in one payment. Some members requested the option to pre-pay for their meals. The invoices will provide information for those interested in prepaying for meals.

- small comb (no rat tails)
- new wash cloth
- bar of soap (small hotel size)
- sample size toothpaste (check expiration date not expired)
- child size toothbrush (single package)
- small stuffed animal (Beanie Baby® size)
- 8 pack box of coloring crayons
- thin 8.5" x 11" coloring book
- small square mirror (approximate size 3"x 3")
- pack of post-it notes
- Small packet of tissues

Operation Smile particularly needs toothpaste (expiration date at least 6 months in the future) and soap!



Personal hygiene items such as dental floss, body lotion, and baby oil are wonderful items, however, they are not included in our Smile Bags. All items we request are the small, travel size for one simple reason—we need to pack 50 smile bags into a box. Large personal hygiene items take up more room.

Any type of food product, like candy and gum, is not packed for Operation Smile missions. Shipping regulations prohibits sending food items across international borders. These items could cause all of our medical equipment and supplies to be guarantined in customs.

Went over breakdown of dues and cost of meals. Returning to Zonta pick the meals vs. Chef's Choice. We do need to vote within the timeframe given in the survey. Option of paying in advance via credit card on PayPal was discussed. Majority will rule.

Fellowship/Awards by Lisa Miner...not here, Julie Ratcliffe did the report. June year end will be on June 17th. They are planning the event. Noted the changes to the April meetings due to Spring Break.

Golden Z Club by Megan Granda: Had a very successful National Eating Disorders week events and 2 speakers. Cynthia and Megan attended the meetings. Working on an International Service project with a group from the Netherlands.
